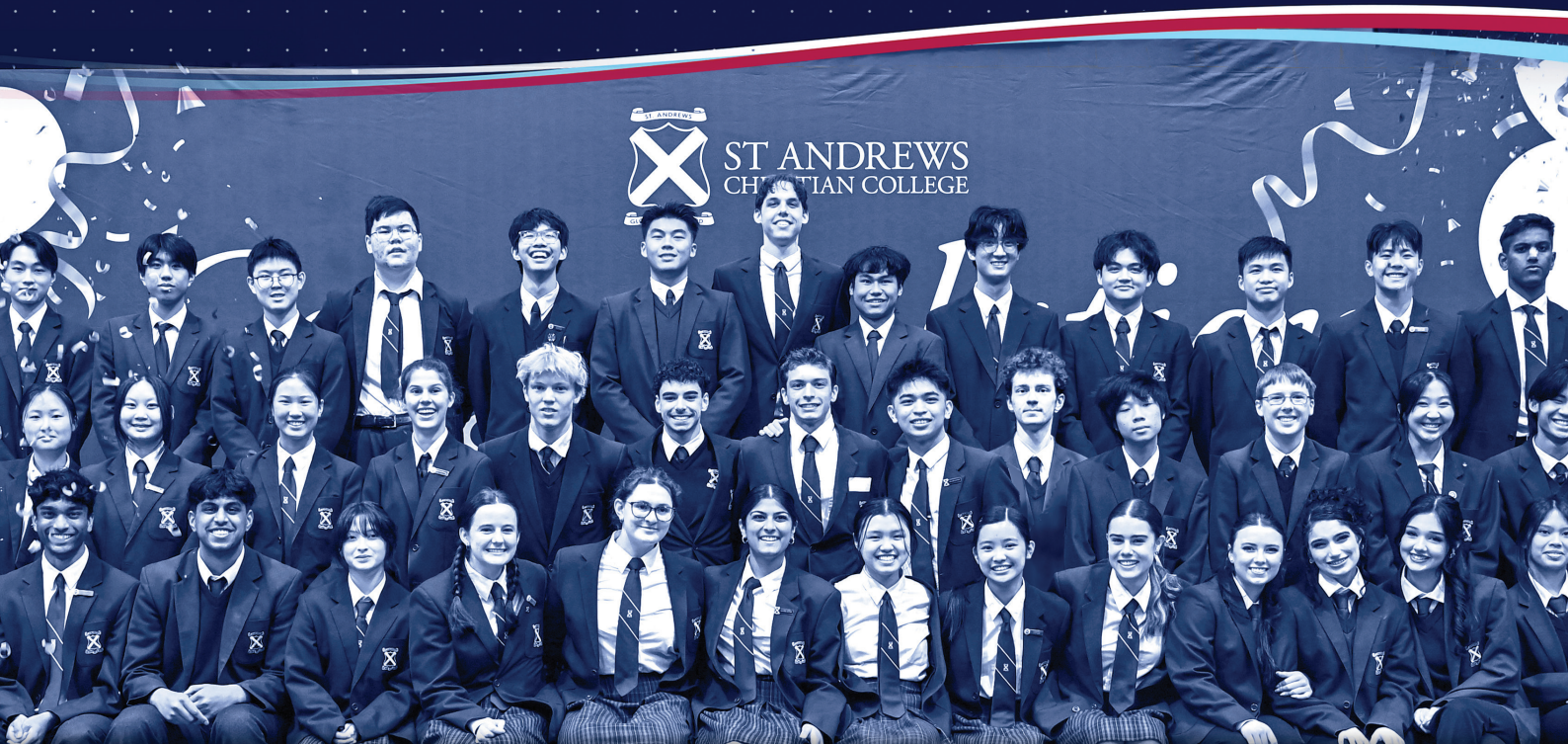

**\*Levies cover the cost of items such as:**

- Teaching materials including photocopying work sheets, art room and stationery supplies
- Prescribed excursions (Year 12 students will be charged for excursions as they occur)
- Primary School Swimming program
- Transportation and facility hire for sports events

- iPad - Primary School
- Laptop - Secondary School

**NOTE:** Excursions/camps are an integral part of the curriculum and the applicable levies are non-refundable.

# 2026 Schedule of Fees

## APPLICATION FEE

A non-refundable charge of \$100 (including GST) is payable when lodging an Application for Enrolment.

## ENROLMENT FEE

A non-refundable enrolment fee of \$1,400 per student is payable on acceptance of enrolment. \$1,000 of the Enrolment Fee will then be credited to the fee account.

## FEE PAYMENT ARRANGEMENTS

In 2026 the College will be using FACTS Tuition Management for families to process school fee account payments. FACTS is an online platform which will allow families to monitor and manage their fee payments. Using FACTS will ensure we meet the required security standards to protect customer data. The expectation is that fees will be paid on a monthly basis from February to November, with a final payment in December to settle any outstanding balance. FACTS will also allow other payment plan options that align to families' financial situation.

In the lead up to the 2026 fees and levies being processed we will provide further information on how to register and set up your payment information in FACTS.

## BURSARY ASSISTANCE

There are limited funds available to provide bursary assistance to parents who find themselves in financial need and may need help in paying the school fees. Information and application forms are available from the College Office.

## BUILDING FUND

Families are invited to donate \$500 each year to the Building Fund. A voluntary charge of \$500 will appear on the fee account but is not charged to the account. If you do not wish to make this donation or would like to donate a different amount, please advise the accounts department and your account will be adjusted accordingly.

**All donations to the Building Fund of \$2 and over are tax deductible. A receipt for tax purposes will be issued in June of each year.**

## VET STUDENTS

Students who undertake a VET subject will be charged the relevant course fee. The fees range from \$2,300 to \$3,300 per subject. Details will be provided by the VET Coordinator. There is no reduction in fees charged by St Andrews if a student undertakes a VET subject.

## SIBLING DISCOUNTS

The following discounts on tuition fees will apply to siblings provided that accounts are paid by the due date:

SECOND CHILD	20% discount
THIRD CHILD	40% discount
FOURTH CHILD	100% discount

## BOOKLISTS

To ensure the correct stationery and textbooks are supplied for Prep to Year 6 students, these items will be supplied directly to the College and an additional cost charged to the fee account. Parents of students in these Year levels do not need to purchase stationery or textbooks.- An additional charge for the Booklist supplies for Prep to Year 6 will be added to the fee account.

Booklists for Years 7 to 12 will be distributed with details of the required textbooks and stationery. We would recommend that you purchase these from Champion Education; however, you are able to purchase them from other suppliers if you wish.

## PARENT PARTICIPATION

The College Board seeks to keep the tuition fees as low as possible. We are greatly helped in achieving this objective by parents' involvement in the Parent Participation scheme.

Families can participate in the scheme by being involved in a variety of activities. During the year notices will be sent out requesting parent help at various events or activities, for example, helping at sports carnivals, covering library books, classroom help or attending working bees.

Parents are required to record the hours they have completed in the Parent Hours Book which is kept in the College Office. You will be charged a Parent Participation fee of \$250 at the commencement of each year and will be credited at the end of each semester for any work done. You will be credited at a rate of \$25 per hour of work completed, up to a maximum of \$250 for the year. The time requirement for each family is ten hours per year.

## CAMP, SPORTS, EXCURSION FUND (CSEF)

Parents who hold a Centrelink Health Care Card are eligible for a State Government grant from the CSEF. Please contact Loretta Hoenen to receive an application form. For students eligible for the CSEF and registered in 2024, a School Savings Bonus of \$400 will be paid to the College and credited to your school fee account in 2025
